to 15:1, depending on the specific application and final dilution. The product can be sprayed on accessible surfaces, diluted for soaking or injected into out-of-service pipelines at dosages of 0.01-1% (water is not potable during

treatment). Incubation times vary by application from 10 minutes (spray) to overnight (soak).

STORAGE: Floran Biogrowth Remover should be stored in tightly closed containers and kept out of the reach of children. Do not

store mixed product, it will become unstable. Floran Biogrowth Remover can be stored for greater than one year in a ventilated, covered location. Floran Catalyst is stable for over one year when protected from heat and direct sunlight.
